

Introduction

This is <u>Not</u> a Full Forensic Audit. This is <u>research</u> that the Election Integrity team has created.

The Election Integrity Team examined publicly available raw data from the North Carolina State Board of Elections (NCSBOE) for ten months to determine if the outcome and integrity of the 2020 election in North Carolina were tainted by fraud.

The Election Integrity Team <u>discovered</u> various irregularities that could have influenced North Carolina's 2020 elections. These factors had an impact on overall voting totals for <u>all candidates</u> in every North Carolina County. This is something that must be treated seriously. The facts and conclusions are based on publicly available data. The North Carolina State Board of Elections has these same raw data files available.

We discovered three types of irregularities that potentially disenfranchise all North Carolina voters: election and voter anomalies, election equipment and software anomalies, and Federal and private grant issues for the 2020 election. The study also provides strong evidence that voting machines were connected to the Internet and that fractional vote counting was used. As a result, we recommend a full forensic audit of the 2020 election in North Carolina as a result of our findings.

The full forensic audit will either prove or disprove our findings, easing the frustration of North Carolinians concerned about the integrity of their elections. Our elections are critical to the freedom of our country, regardless of which party a voter belongs to. We will not have a free country unless we have fair and honest elections.






100 IP Breaches in NC
